Hi Wendy,

I've been traveling and I wanted to be at my computer to see what details you had sent. I was disappointed to find the document you sent does not include any information that was requested on February 26th or the information requested on May 24th. Both of these requests were made pursuant to freedom of information rules and requirements.

I'm requesting once again that the Board produce the following information **for every community water system water tap**, not just the ones you think are deficient.

As stated in the May 3 email, the Board and paid management have collected pictures of backflow prevention devices, including each device's make, model, and installation date. So, by your own admission, all the requested information requested on February 26 is readily available for me to review. (note all should have been made available in the install report when meters were installed)

The information requested is crucial for ISD members to know that the Article V regulation is being fully and fairly implemented. In addition, it will allow members to determine the extent of the budget overruns of the "Remote water meter and Backflow prevention project" imposed on members and still not accounted for on the ISD website. (see W. Johnson's e-mail of April 10)

Please let me know if you have any questions about this request and its timely completion.

Wendy, I recommend that you review the following documents: the updated meter replacement schedule spreadsheet (attached below) and your PDF titled "Backflow Preventers - information request 5.14.24." Based on my understanding and what is indicated in the spreadsheet, it seems that the exceptions PDF contains an incomplete and inaccurate list of water taps that do not have the correct double-check backflow prevention systems installed.

Dear Skyline Ranch ISD Board members and Homeowners,

I would like to explain why I voted against the proposed expenditures on the Skyline Ranch water system, & I hope you will join me in voting NO!

Skyline Ranch ISD was formed to operate and maintain Skyline's paved roads and our water systems. The oldest part of the road and water systems is the distribution system. It was installed 55 years ago and is near or beyond its planned life. The distribution system was put in before we paved the roads and before we drilled our two operating water wells.

The water distribution system has failed repeatedly over the last ten years, but the water supply system (wells, pressurized tank) has never failed to meet our demand. The current Board has not properly evaluated the priority for system upgrades. Their emphasis is on the supply system and replacing our water meters.

If you ask homeowners why they have had unexpected service interruptions, the answer in almost every case is that the distribution (piping) system has failed, not the pumps or wells. Distribution is the highest reliability risk, not supply. The Board has given priority to the supply system because the distribution system upgrade cost estimates are \$7-\$10 million dollars and there are no grants available for the distribution system.

Prior Boards and this Board have not properly accumulated reserves for replacement and upgrade of our facilities over their lifetime which is a fundamental role of an ISD. We had 55 years to build the funds to upgrade the distribution system but did nothing.

In 2020 the ISD, working with State agencies, contracted with Nelson Engineering to study our water system. The final report was received in July 2021. The study used 2018-2020 water use data, which was a time of high leaks. They did not correct the data for the leaks and estimated the following demands:

"Model of Existing demand = 262,200 gpd, at a rate of 183 gpm" 21% above observed "Estimated Future demand= 400,100 gpd and a rate of 278 gpm" 85% above observed


The actual data is shown below, the solid blue line is the water pumped and the solid red line is the water measured and billed using our old water meters. It shows that 2018-2020 were years of 37% leakage. After the leaks were fixed half way through 2021 our water usage has dropped.

From hard data, we did not need new water meters and we do not need to increase the supply side of our water system.

Homeowners and the ISD have spent more than \$200,000 and \$80+ to each homeowners' tax bill for 20 years putting in new water meters that we did not need. Now they want to spend more than a million dollars and add \$618.05 per year for each homeowner' tax bill for 20-years on increasing supply that we do not need. Just think what a \$7,000,000+ loan will cost to repay, we should be saving not spending money.

We need to be building our water reserve account so that we can replace our aging distribution system.
