NOTICE OF ELECTION

PUBLIC NOTICE IS HEREBY GIVEN that the Board of County Commissioners has directed that the question of the organization of the Skyline Improvement and Service District be submitted to the electors of the proposed District at an election to be held at the residence of Earl and Mariana Auge at 250 North Westridge Road in the Skyline Ranch Subdivision, from 7:15 a.m. to 2:15 p.m. on September 12, 1989. Bob Marshall (five year term), Bob Norton (four year term) and Fred Staehr (three year term) have been nominated as the three initial board members of the proposed District.

A description of the purposes of the District is as follows:

- (a) All required roadway maintenance, including snow removal or clearance for roads or streets, and the sanding of iced roadways as necessary or appropriate for convenient access to property within the district;
- (b) The opening, widening, extending, straightening and surfacing in whole or part of any road, street or parking lot;
- (c) The construction, improvement and maintenance of bridges, culverts, gutters, drains, and works incidental to any street improvement;
- (d) The construction, improvement and maintenance of sidewalks, curbs, pedestrian ways, and other public ways;
- (e) The acquisition and ownership or leasing of real or personal property, including easements and rights of way, within or without the district for district purposes;
- (f) The performance of all services necessary to promote and protect the health and welfare of residents in the District and the value of the property therein;
- (g) The acquisition or construction of improvements or providing services authorized herein by contracting for the same with any public or private agency, institution or person for the furnishing of such services or improvements;
- (h) The furnishing or performing any special local service which enhances the use or enjoyment of any improvement or facility;

- (i) Any and all things necessary or required to carry out the purposes of W.R.S. Section 18-12-101 through 18-12-140;
- (j) Water, sewage, solid waste disposal and other sanitary systems and facilities; and the provision of services for the collection and supply of the District with water for domestic use and the provision of services for the collection, treatment and disposal of sewage and solid waste disposal;
- (k) The collection, and disposal of garbage and refuse matter;
- (l) Parks, including but not limited to playgrounds, golf courses, swimming pools, recreation buildings and other facilities for public recreation; and
- (m) The lighting of street improvements and maintenance thereof.

The proposed boundaries of the District are within Teton County, Wyoming, as follows:

All of the Skyline Ranch - First Filing and Second Filing, and all of the individual tracts numbered 2-1 through 2-10, 3-1 through 3-33, and 3-35, which are commonly referred to as Skyline Ranch, as further described by metes and bounds in the Petition for Formation of this District on file with the Clerk of Teton County, Wyoming.
